## From the Rector's Desk

Recently I delivered a homily wherein I encouraged you to dream—dream big, dream small, but dream, nonetheless. Although I've not heard from any of you regarding your dreams for St. Peter's or what role you might play in those dreams, our future is going to change. I said as much in the homily, quoting the old saying: "If you want to make God laugh, make plans." But I must confess, I didn't expect change to come the way it did or quite as soon as it did.

First, our organist and choirmaster, Sam Bruce, resigned effective October 31. He was starting his eleventh year with us, having come to us from St. Mary's, Goochland at the invitation of the Rev'd Brian McGurk. Sam had lived through two incumbents, a priest-in-charge, and at least one interim. He had served us faithfully throughout his entire tenure. We don't know what the future holds for him, but we wish him well.

So the music program will be changing. As I told Jeannine Uzel, our search consultant and Sam's predecessor, any time a new organist mounts the bench the organ tends to sound different. The new person often goes off into areas of the organ the previous organist didn't, with new stops, new volumes, new combinations, and new music. Sam wasn't Jeannine, and that required some adjustment; Sam's successor won't be him, and that will require adjustment, too. *What are your hopes and dreams for the new choirmaster and organist, or for St. Peter's music program in general?*

Second, Sam's resignation was followed two days later by the resignation of Adriane Marshall, our Youth Mission Trip coordinator. Adriane had held that position about as long as Sam had held his. I think she'd gone on thirteen mission trips and led ten of them. Now that program will be changing as well. We'd done some minor tweaking of the program over the years, but now it will be a major overhaul and revision of the Youth Mission Trip program. The task group will be looking at where we go, who we work with, how it's funded, how each participant is individually funded, who's going to lead it, and much more. *What are your hopes and dreams for the Youth Mission Trip program and/or for its new leader?*

Finally, we've been celebrating a lot of baptisms lately. That's good to see; it's a sign of a growing church! The "Five Marks of Mission" were developed by the Anglican Consultative Council between 1984 and 1990, and have won wide acceptance among Anglicans. They have given parishes and dioceses around the world a practical and memorable "checklist" for mission activities. Here they are:

- To proclaim the Good News of the Kingdom;
- To teach, baptize and nurture new believers;
- To respond to human need by loving service;
- To seek to transform unjust structures of society, to challenge violence of every kind and to pursue peace and reconciliation; and
- To strive to safeguard the integrity of creation and sustain and renew the life of the earth.

*What are your hopes and dreams regarding how we live out these "Five Marks of Missions"?*

The 2<sup>nd</sup> Annual *Sarah's Memorial Golf Tournament* was held at The Club at Viniterra golf course on September 20 and it was an overwhelming success! The tournament exceeded all expectations by depositing \$26,000 into a scholarship endowment with the College of William and Mary Foundation in the memory of Sarah Lindsey Gupta. With this additional funding, the initial endowment goal of \$50,000 has been reached, which allows the college to begin the scholarships.

Sarah passed away in November 2011 with a rare form of adrenal cancer. She was a former teacher at the New Kent Middle School for a number of years, an alumna of the College of William and Mary, and a member of St. Peter's. The goal of the endowment is to offer scholarships to students pursuing a degree in education or the arts at William and Mary. According to Patrick Evelyn, who initiated and led the tournament, "Meeting the initial endowment goal in two short years is beyond anyone's expectations." He went on to say, "I knew Sarah had a large influence on the many people that she touched, but this outpouring was truly a blessing."

Over 120 golfers participated in the tournament along with 70 hole sponsors, 12 tournament sponsors, and numerous donations and prize offerings. The weather could not have been any better and everyone enjoyed a great day at Viniterra. The food, the fun, the friendly competition, and the prizes were truly the order of the day. So many supporters joined together for this admirable achievement!

Because of these wonderful successes, Patrick and his committee are already planning for next year's tournament to further enhance the scholarship fund. According to Patrick, "We could have never had this spectacular accomplishment without the support and generous donations from so many people, businesses, and surely our church. We sincerely thank them for their participation and look forward to seeing everyone next year."


